This year, the NAC was represented by **Melissa Bernstein, Assoc AIA** from the Pennsylvania region and **Cesar Gallegos, Assoc AIA** from the Texas region. We also had representation from The American Institute of Architects (AIA) by **Erin Murphy, AIA** and **Kevin Fitzgerald, AIA** as well as the AIA's 2012 president **Jeff Potter, FAIA**.



The conference was energizing and awakening even for people like us who have been out of the school for several years. The students were engaged by their tours, seminars, and general sessions and of course the ever-so-famous role call where the schools' presence is acknowledged by songs, and school pride.

Phoenix was a warm 75 degrees in late December, which made it ideal for the tours throughout the city. Students were able to appreciate the city's influential architectural works by famous architects including Frank Lloyd Wright, Antoine Predock and Richard Meier.

The discussion was followed by an attentive, lively question and answer session about diversity, leadership, and responsibility.

Throughout the evenings there were several events for the students to socialize and participate in various locations of Phoenix which have been renovated to become prime event spaces. Finally the event ended with the New Year's gala where all the students joined in together to receive the New Year. The event was a fun environment for all.
