### **AIA Strategic Council Regional Representative Update: February 2, 2016**

- I. Since Last AIA New England Board Meeting
  - A. The AIA Board of Directors and Strategic Council participated in Governance Week at the AIA Headquarters on December 1-5, 2015. This included the following events:
    1. Strategic Council Orientation: As a member of the new Strategic Council Class of 2018 (serving from 2016 through 2018), I participated in an orientation session during which the Strategic Council, the roles and responsibilities of a Council member, opportunities to participate, the AIA's new Strategic Plan, and other aspects of the role were explained. This was presented by members of the Class of 2017, with whom I participated with during conference call sessions as my term started early and I was initially assigned to this Class. As indicated in the AIA Bylaws:
      - a. The Strategic Council shall advance the profession of architecture by informing the Board and other Institute bodies of important professional issues and opportunities. It shall have the following authority and responsibilities:
        - Identify issues and opportunities for Institute consideration;
        - Disseminate information and insight to constituencies about the Institute's priorities and activities;
        - Ensure that its composition reflects and represents the geographic and demographic diversity of the profession;
        - Elect at-large Directors to the Board of Directors;
        - Commission a rigorous, regular process to survey the profession, identify opportunities and threats, and inform the goals, objectives and strategies of the Institute in order to help with the Institute's planning process;
        - Develop and recommend public policy positions on behalf of the Institute for consideration and potential approval by the Board;
        - Engage in strategic planning for the Institute;
        - Review the Institute's operating plan and budget, and provide its endorsement and/or recommendations for the Board's consideration;
        - Engage in leadership development; and

- Subject to Board approval, propose such committees, ad hoc workgroups and task forces as it deems appropriate to advance its purpose.

b. There can be up to 60 members.

2. Joint Board and Strategic Council Meeting: A combined session to hear presentations on behalf of the finalists for the AIA Gold Medal and Firm of the Year, followed by voting.
3. Strategic Council Assembly: Presentations and interactive sessions by each of the 2015 Study Groups: 1) Awards, 2) Business Model Innovation, 3) Culture, 4) Diversity and 5) Relevance.

- B. Facebook Posting: Notice the Board and Strategic Council from Jay Stevens, AIA Senior Vice President and General Counsel, which I thought was of interest:

“We have learned that the attached Facebook posting has been the subject of attention among some architects. I will remind you that the subject of free services was central to our 1990 antitrust consent decree with the U.S. Department of Justice. Among other things, the AIA agreed not to do anything that might be seen as prohibiting or restraining AIA members from ‘providing free services,’ or suggesting that such conduct was unethical, unprofessional, or contrary to any policy of the AIA or any of its components. Although the consent decree has terminated, the underlying considerations remain very much alive in federal antitrust law and are cited in the AIA Code of Ethics. We can assure you that the posting is in no way sponsored or supported by the AIA. In order to ensure that we clearly maintain our distance from the posting, we ask that you not participate in any way in the online discussion surrounding it.”
